## BURSARY AND SCHOLARSHIP PROGRAMMES

### NSFAS AND UCT FINANCIAL ASSISTANCE

The National Student Financial Aid Scheme (NSFAS) runs a central application for funding application system. First-time applications for financial aid, as well as funding renewal for those students who are already recipients of NSFAS funding, will be handled centrally via NSFAS. Although applicants may have applied to multiple institutions for admission to study, only one financial aid application directly to NSFAS will be required.

UCT will be part of this new student-centred application model and all students and learners who need financial assistance should apply to NSFAS via the latter's on-line application system [www.nsfas.org.za](http://www.nsfas.org.za). The University also provides for a GAP funding programme for those that are rejected by NSFAS on financial eligibility grounds. Information about UCT's GAP funding programme is available on the website.

The University provides a well-rounded financial assistance system to those that meet the qualifying criteria for financial assistance. The Student Financial Aid website (<http://www.dsa.uct.ac.za/student-funding-administration/financial-assistance/overview/>) provides comprehensive details on the financial assistance programmes.

Applicants who do not apply by the closing date will not be considered for funding.

### BURSARIES

This handbook provides applicants and students with information on sponsors that are offering bursaries and or loan assistance. These must be applied for as indicated.

Students should regularly consult Faculty notice boards, the Careers Services, and the Student Financial Aid website for information on any other sponsors who may be offering financial assistance. Depending on when these become available, they may not necessarily be advertised in this booklet.

### SCHOLARSHIPS

There are numerous scholarships that are administered by the University each with their own special conditions. The types of scholarships available are:

1. **Sundry Scholarships:** Some scholarships require application. Their closing dates and conditions are publicised on notice boards in the academic and residence buildings.

2. ***Vice-Chancellor's scholarships:*** These scholarships are across Faculties and reward academic excellence in the matriculation exam in particular categories and no application is required by school leavers.
3. ***Entrance Scholarships:*** The University has established several Entrance Scholarships. These are awarded to new first year students. Each of these scholarships will have specific conditions and criteria. No application is required for these scholarships as applicants will automatically be considered should they meet the conditions of the scholarship.
5. ***Named Entrance Scholarships:*** The University has several named entrance scholarships. Each has specific conditions which may be certain matriculation subjects, courses of study or hometown. No application is required for these scholarships as applicants will automatically be considered should they meet the conditions of the scholarship.
6. ***December Scholarships:*** The University has several scholarships for those who perform meritoriously in the end of year examinations at university. They range in value and in length of tenure. No application is required.
7. ***Sports Scholarships:*** The University has established several sports scholarships, which are available to new first year students who have represented their country at national school level. To apply, send your sports C.V. and a list of references to: The Manager, Sports and Recreation, Department of Student Affairs, University of Cape Town, Private Bag X3, Rondebosch, 7701, by 30 September of the year before you intend to study at UCT.

#### **PROGRESS REPORTS AND RESULTS REQUIRED BY EXTERNAL SPONSORS AND SCHOLARSHIP/ BURSARY GRANTING AGENCIES**

If you hold an outside award, where the sponsor requires the University to submit an academic progress report or your final results for the year, you must complete the relevant section on your Registration Form when you register each year. It is important to fill in the full name and address of the sponsor. If you are awarded an external bursary or scholarship after registration, you must advise the Student Fees Office, Kramer Law Building before mid-May of the name and address to which a progress report should be sent. It is your responsibility to ensure that your sponsor obtains your progress reports or results. If you forget, your award may not be renewed.
